Public Consultation for the Gender Equality Add-On



While the core **4C Code of Conduct** does not allow for discrimination and requires that equal rights are secured with respect to gender, **4C sees further potential to address the existing disparities and promote women empowerment in coffee production**. Therefore, we now provide a solution for our system users who wish to address the need for gender equality on a deeper level: The **"4C Gender Equality Add-On" (GE Add-On)**.

We are proud to announce the launch of the <u>Public Consultation</u> for our new **Gender Equality Add-On**. Public Consultation is an integral part of the 4C system as it facilitates exchange with the coffee community and helps us to continuously improve our system.

New 4C Pesticide List Published – Valid from January 2024

4C has revised and updated its **Pesticides List**. The 4C Code of Conduct aims to foster safer workplaces, better living conditions, and protect the environment. Thus, it includes **three lists on pesticides**. The lists are divided into **Unacceptable** pesticides, **Red List** pesticides and **Yellow List** pesticides.

To stay in line with the most recent international protocols and scientific evidence, the criteria to update 4C's list was based on the **Pesticide Action Network (PAN) Highly Hazardous Pesticides** publication of 2022.

The new Pesticide List is now available to the 4C Website and will apply from January 2024.
