## Recap of the 4C Regional Stakeholder Conference in Campinas, Brazil



On the 13th of June 2023, **170 coffee and sustainability professionals** as well as government officials gathered in Campinas for the **4C Regional Stakeholder Conference on "New Requirements for Coffee Exports and Latest Developments in Sustainability Certification."**

Throughout the event, **industry-leading experts** from the Brazilian coffee sector, including representatives from **Cecafé**, the **State Secretary of Agriculture of Espírito Santo** and the **Executive President of CNC Brazil** shared their insights. Global coffee experts from the **International Coffee Organization** and **Global Coffee Platform** further

guided thought-provoking discussions on the implications of the latest developments in sustainability regulations and requirements. Innovative technical approaches for addressing sustainability challenges were presented by experts from **Meo Carbon Solutions**, **Global Risk Assessment Services (GRAS)** and **4C**, such as the **4C Carbon Footprint Add-On** for reducing greenhouse gas emissions in coffee production and supply chains, risk assessment supported by **remote sensing** as well as solutions for reliable **traceability** and comprehensive **data collection** to facilitate proof of compliance with EU regulations.

The event offered participants the opportunity to engage with prominent stakeholders, gain insights from industry experts, and contribute to meaningful discussions. With a focus on **fostering collaboration and providing valuable networking opportunities**, the event facilitated connections among professionals in the coffee and sustainability field and acted as a **catalyst for new partnerships** and knowledge exchange.

## Update on EU No-Deforestation Regulation (EU DR) – Date announced!



With its publication in the Journal of the European Union, the timeline for the new **EU No-Deforestation regulation** has been officially confirmed. The regulation will **come into effect on 29 June 2023**, and will be **fully applicable from 30 December 2024**, with a six-month extension granted to SMEs.

Within 18 months of the regulation's entry into force, the Commission will classify countries or regions as being of **low, medium, or high-risk** regarding deforestation. The proportion of checks will be based on the risk level: 9% for high-risk countries, 3% for standard-risk countries, and 1% for low-risk countries. The relevant EU authorities will require access to **information provided by companies**, such as **geocoordinates**, and conduct checks using, for example, **satellite monitoring** to verify the origin of the products. Together with our partner GRAS, we are working on **solutions to support coffee companies in both exporting and importing countries** with complying with the EU DR and will keep you informed about further developments.
